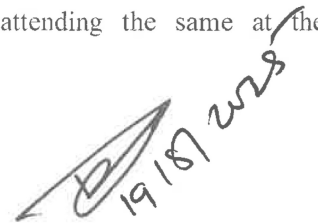

MINUTES OF THE MEETING OF BID EVALUATION COMMITTEE (BEC) HELD ON 19/08/2025 AT

EVALUATION OF TECHNICAL BID

Name of Work: Maintenance of Works to Newly declared NH-702C (Dhodar Ali) through STMC from Ch.126/700 (Garmur Chariali) to Ch.154/665 (Namtola Tiniali, Sonari)(L=27.965 Km.)(Design chainage Ch. 17/400 to Ch. 41/750 of NH-702C) under PWD, Jorhat NH Division, Jorhat in the state of Assam for the year 2025-26.

Bid Value: Rs.189.863 Lakh (Excluding 18% GST & Including 1% L.C.)

Time of Maintenance: - 12 (Twelve) months

The RFP for the work was issued by the Chief Engineer, (NH Works), PWD Assam vide letter no. NIT No- NHR.20/2025/3 dated 21/06/2025 and Extension Notice No. NHR.20/2025/8 dated 25/07/2025. The RFP and the Bidding documents were made available in the CPPP, MoRT&H of <https://eprocure.gov.in> from 14.00 hrs on 24.06.2025 to 14.00 hrs on 13.08.2025.

Technical Bid opening: -

The online technical bids were opened on 14.08.2025 after 14.00 hrs. in the Office Chamber of CE (NH Works) in presence of the Bid Evaluation Committee (BEC) members & representatives of bidders. Total 5 (Five) nos. of bids from the following bidders were received through online mode in the portal of CPPP website <https://eprocure.gov.in>:-

1. Zafrul Barik, Sivsagar, Assam
2. Sharot Changmai, Khamun Gaon, Pohuchungi, Sivasagar-785691
3. Vargov Traffic Device Systems, 198, Mitra Bora Lane, DB Road, Jorhat, Assam.
4. Risha Infrastructure, K.C. Road, Chatribari, Guwahati-08.
5. Sanjay Kumar Singh, Chirwapatty Road, Tinsukia, Assam

The online uploaded documents were downloaded and authenticated by comparing with the hard copies (original) submitted by the participating bidders. On verification of the hard copies of documents, it was noticed that the bidder Sanjay Kumar Singh has not submitted the hard copy of the bid document. Further it was noticed that, the bidder Vargov Traffic Device Systems has not submitted the physical copy of Bid Security. The other 2 (Two) bidders have submitted the physical copies of all the requisite documents. The BEC decided to go ahead with evaluation of the following 3 (Three) bidders:

1. Sharot Changmai, Khamun Gaon, Pohuchungi, Sivasagar-785691
2. Risha Infrastructure, K.C. Road, Chatribari, Guwahati-08.
3. Zafrul Barik, Sivsagar, Assam

(B) Evaluation of Technical Bids: -

To establish the responsiveness of each & every individual's technical bids, the qualification information submitted online by the bidders have been examined on the basis of technical qualification criteria laid down in the bidding documents and compiled in the form of a statement –“TABLE FOR EVALUATION

OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS" placed before the Bid Evaluation Committee.

The meeting of Bid Evaluation Committee (BEC) for technical evaluation of bids is held on 19.08.2025 at the office chamber of the Chief Engineer, PWD (NH Works), in presence of Chief Engineer, PWD (NH Works) as Chairman of Bid Evaluation Committee (BEC) along with other members of BEC. The Bid Evaluation Committee verified and examined the documents of the technical bids & all other relevant papers. The deliberations of the Bid evaluation committee are as follows: -

1. **Sharot Changmai**, Khamun Gaon, Pohuchungi, Sivasagar-785691: The qualification information furnished by the bidder is found to be **in order** as per stipulation of RFP.
2. **Risha Infrastructure**, K.C. Road, Chatribari, Guwahati-08: The qualification information furnished by the bidder is found to be **in order** as per stipulation of RFP.
3. **Zafrul Barik**, Sivsagar, Assam: Bidder fails to submit the documentary evidence of owning several key machineries. Hence bidder is liable to be disqualified as per Clause 4.1(d) & 4.3B (b)(i) of the RFP.
