MINUTES OF THE MEETING OF BID EVALUATION COMMITTEE (BEC) HELD ON 19/08/2025 AT THE O/O THE CHIEF ENGINEER, PWD (NH WORKS), ASSAM, CHANDMARI, GUWAHATI- 3 FOR EVALUATION OF TECHNICAL BIDS FOR THE WORKS

Name of Work: -Maintenance works through STMC from Km 54/000 to Km 80/900 (Doulasal to Barpeta town section) on NH-427 (Total length= 26.90 Km) under PWD, Guwahati NH Division in the state of Assam.

Job No :- Job No. RW/GHT/NH-427/AS/STMC/2025-26/15

Bid Value:-Rs. 2,17,38,850.00 (Excluding 18% GST & Including 1% L.C.)

Time of Maintenance: - 12 (Twelve) months

The RFP for the work was issued by the Chief Engineer, (NH Works), PWD Assam vide letter no. NIT No- NHR.20/2025/3 dated 21st June' 2025 and Extension Notices No. NHR.20/2025/05 dated 10th July' 2025 and NHR.20/2025/08 dated 25th July'2025. The RFP and the Bidding documents were made available in the CPPP, MoRT&H of <https://eprocure.gov.in> from 14.00 hrs on 24.06.2025 to 14.00 hrs on 13.08.2025.

Technical Bid opening: -

The online technical bids were opened on **14.08.2025 after 14.00 hrs.** in the Office Chamber of Chief Engineer, PWD, (NH Works) in presence of the Bid Evaluation Committee (BEC) members & representatives of bidders. Total 4 (four) nos. of bids from the following bidders were received through online mode in the portal of CPPP website <https://eprocure.gov.in>.-

- (i) Rana Construction & Engineering Pvt. Ltd, Suraj Complex, Ulubari, Guwahati – 781007.
- (ii) M/S Padmavati Construction, Paglasthan, Bongaigaon, Assam-783380.
- (iii) New Horizon Enterprise, Larika Green Valley, P.O. Dharapur, P.S. Azara, Kamrup Metro, Assam-781014.
- (iv) Abdur Rekib, North Bangaon, P.O. Rangia, P.S. Rangia, Kamrup – 781354.

The online uploaded documents were downloaded and authenticated by comparing with the hard copies (original) submitted by the participating bidders. On verification of the hard copies of documents, it was noticed that all the 4 (four) bidders have submitted requisite documents, bid security and cost of bid document in the Bharatkosh Portal. The BEC decided to go ahead with evaluation of Technical bids of all the 4 (four) numbers of bidders:-

Evaluation of Technical Bids: -

To establish the responsiveness of each & every individual's technical bids, the qualification information submitted online by the bidders have been examined on the basis of technical qualification

criteria laid down in the bidding documents and compiled in the form of a statement –“TABLE FOR EVALUATION OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS” placed before the Bid Evaluation Committee.

The meeting of Bid Evaluation Committee (BEC) for technical evaluation of bids is held on 19.08.2025 at the office chamber of the CE, PWD (NH Works), in presence of CE, PWD (NH Works) as Chairman of Bid Evaluation Committee (BEC) along with other members of BEC. The Bid Evaluation Committee verified and examined the documents of the technical bids & all other relevant papers. The deliberations of the Bid evaluation committee are as follows: -

- (i) **Rana Construction & Engineering Pvt. Ltd**, Suraj Complex, Ulubari, Guwahati – 781007: The qualification information furnished by the bidder is found to be **in order** as per stipulation of RFP.
- (ii) **New Horizon Enterprise**, Larika Green Valley, P.O. Dharapur, P.S. Azara, Kamrup Metro, Assam-781014: The qualification information furnished by the bidder is found to be **in order** as per stipulation of RFP.
- (iii) **Abdur Rekib**, North Bangaon, P.O. Rangia, P.S. Rangia, Kamrup – 781354 : The qualification information furnished by the bidder is found to be **in order** as per stipulation of RFP.
- (iv) **M/S Padmavati Construction**, Paglasthan, Bongaigaon, Assam-783380: The bidder has not submitted experience certificate in works of similar nature. Hence, the bidder is liable to be disqualified as per clause no.4.1(c) of the RFP.
