

**MINUTES OF FINANCIAL BID EVALUATION COMMITTEE MEETING HELD ON 26.08.2025 FOR THE WORK** Short Term Maintenance Contract to NH-329A, (Diphu- Dhansiri- Dimapur Road) from Km 0.000 to 37.000 of Diphu- Dhansiri- Dimapur Portion, (Total Length = 37.000 km) for the Year 2025-26 under Bakulia NH Division in the state of Assam. (Job No. RW/GHT/NH-329A/ AS/STMC/2025-26/23)

**BID VALUE: Rs.190.25093 Lakh.**

In the Minutes of Technical bid evaluation meeting held on 19.08.2025, the BEC recommended for opening of the financial bid of the technically responsive bidder to assess the third criteria regarding "prices are reasonable as compared to market values" as per Ministry's Circular No. RW/NH-33044/25/2024-S&R (P&B) (Computer No. 240989) dated 28.08.2024 on "Acceptance of Single bid for National Highway works". Accordingly, the financial bid of the technically responsive bidder is opened on 26.08.2025 by the B.E.C under the chairmanship of Chief Engineer PWD, (NH Works), Assam and in presence of other members of the BEC and bidders/ bidder's authorized representatives. The summary of the financial bids opened is as follows.

Since the sole bidder M/s RISHA INFRASTRUCTURE, K.C. ROAD, CHATTRIBARI, GUWAHATI-781008 has quoted 33.96 % below the amount put to tender, hence the BEC opined that the rate quoted by the bidder may be considered as reasonable and BEC noticed that all the 3(three) conditions are satisfied as per Ministry's Circular No. RW/NH-33044/25/2024-S&R (P&B) (Computer No. 240989) dated 28.08.2024 on acceptance of Single bid for National Highway works. In view of this Bid Evaluation Committee (BEC) further recommended that the work may be awarded to sole L1 bidder at his own quote price. In keeping with provision of clause 32.1 of RFP the BEC has recommended that the bidder must provide a performance security of 3% (three percent). Additionally, the bidder required to furnish an additional performance security along with the performance security of 3% (three percent). The calculation for the additional performance security for the unbalanced bid is determined as follows: @20% of the difference in the (a) Estimated Project Cost (as mentioned in RFP)-20% of the Estimated Project Cost and (b) the Bid Price offered by the selected Bidder. [i.e. 20% of {(Rs. 1,90,25,093.00- 0.20 x Rs. 1,90,25,093.00)- Rs. ₹ 1,25,64,171.00}] = Rs. 5,31,180.68. Further 3% amount of the Bid Price offered by the L1 bidder is =3% of Rs. 1,25,64,171.00= 3,76,925.13. As provided in the MoRT&H's circular no. NH-37015/01/2022-H-Part (1) (Comp No. 212632) dated 31.08.2022 the maximum limit of additional performance security shall be limited to 3% of the Bid price offered by the L1 bidder. Comparing both the calculation the additional performance security that shall be obtained from the L1 bidder is found to be Rs. 3,76,925.13. Further, approval of MoRT&H for realization of additional performance security from the L1 bidder shall be obtained as per MoRT&H's circular no. NH-37015/01/2022-H-Part(1) (Comp No. 212632) dated 31.08.2022.

In view of the above, the Bid Evaluation Committee (BEC) decided that, since the L1 bidder has quoted Abnormally Low Bid (ALB), clarification for such low bid along with detailed justification shall be obtained from the L-1 bidder.

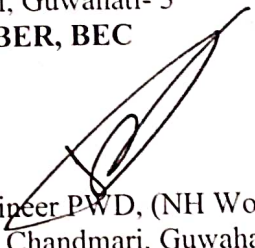
