(i) As per point x(f) of Clause 3.4 of the Letter of Invitation to Consultants in the RFP, if more than 3 CVs score less than 75% marks or the Team Leader cum Senior Bridge Engineer scores less than 75% marks, the proposal shall be considered non-responsive. In this case, the CV submitted by the bidder for the Team Leader cum Senior Bridge Engineer scores less than 75%. (ii) MOU found enclosed but details regarding role and responsibility of Associate Company as per Appendix-M is not found enclosed.	Non-Responsive
