1. The Chairman welcomed the Committee members and requested the Superintending Engineer (NH) Madurai to appraise the action taken on the direction of SLEC during its meeting held on 20.08.2025. The Superintending Engineer (NH) Madurai submitted that clarifications were sought from the bidders **(1) M/s. AF Infrastructure Pvt. Ltd, (2) M/s. Prithvi & Co, (3) M/s.CDR Infracon Limited and (4) M/s.KMC Associates** vide Lr.No.TRP76/2025/JDO-1/ Dated.21.08.2025 and requested to furnish their replies before 29.08.2025 @ 1500hrs in the prescribed format as mentioned in RFP.

2. The Superintending Engineer (NH), Madurai informed that all four bidders have submitted their replies within the given time. However, bidder M/s. Prithvi & Co. has not submitted the required 'Certificate from Govt Authority / Clients for Experience under Approved Subcontractor'.

3. Based on the uploaded documents and clarifications obtained by the Superintending Engineer (NH) Madurai, the evaluation committee has evaluated the technical bids of the five bidders viz **(1) M/s. K.S. & Company, (2) M/s. AF Infrastructure Pvt. Ltd, (3) M/s. Prithvi & Co, (4) M/s. CDR Infracon Limited and (5) M/s. KMC Associates** and brief of the findings are as under:
