You are also requested to furnish Performance Security for an amount of Rs. 13,12,84,110/- (Rupees Thirteen Crore Twelve Lakh Eighty Four Thousand One Hundred Ten Only) and Additional Performance Security for an amount of Rs. 27,13,20,493/- (Rupees Twenty Seven Crore Thirteen Lakh Twenty Thousand Four Hundred Ninety Three Only) as per Clause 2.21 of the RFP within 30 (thirty) days of receipt of this Letter of Acceptance (LOA). In case of delay in submission of Performance



Security and Additional Performance Security, you may seek extension of time for a period not exceeding 60 (Sixty) days in accordance with Clause 2.21 of RFP.

5. In case of failure of submission of Performance Security, Additional Performance Security and Security against Damages (if any) within the additional 60 (Sixty) days' time period, the award shall be deemed to be cancelled and Bid security shall be encashed by the Authority as per Clause 2.21 of the RFP.
