

Minutes of Meeting held on 21.08.2025 for evaluation of financial bids for tender to carry out independent road safety audits and suggesting rectification measures for black spots (1.Jashpur Road Kali Mandir, NH-78 2.Dubdubi More NH-78 3.Bazar Tand ,Silam Raidih,NH-78 4.Jorda Jaam, Gumla,NH-78) in the State of Jharkhand.

The bid for carrying out independent Road Safety Audits and prepare estimate for rectification of identified Black spots 1.Jashpur Road Kali Mandir, NH-78 2.Dubdubi More NH-78 3.Bazar Tand ,Silam Raidih,NH-78 4.Jorda Jaam, Gumla,NH-78) was invited vide Tender Ref. no. RW/Ranchi/Road Safety/2025-26/2 on 09.07.2025.

2. The technical bid for the subject tender was opened on 18.07.2025. The evaluation of the technical Bids was done by the committee on 08.08.2025 wherein Evaluation Committee unanimously recommended the opening the financial bids of Technical Responsive bidders as follows:

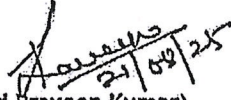

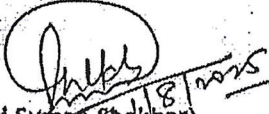
