

Minutes of Meeting held on 21.08.2025 for evaluation of financial bids for tender to carry out independent road safety audits and suggesting rectification measures for black spots 1.Niche Bazar, Simdega NH-143 2.Fulwatangar NH-143, Simdega NH-143, 3.Gadha Nala, Simdega, NH-143, 4.Keriya Dembutoli, Simdega, NH-143 in the State of Jharkhand.

The bid for carrying out independent Road Safety Audits and prepare estimate for rectification of identified Black spots (1.Niche Bazar, Simdega NH-143 2.Fulwatangar NH-143, Simdega NH-143, 3.Gadha Nala, Simdega, NH-143, 4.Keriya Dembutoli, Simdega, NH-143) was invited vide Tender Ref. no. RW/Ranchi/Road Safety/2025-26/3 on 09.07.2025.

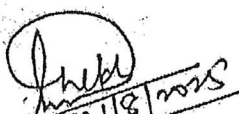

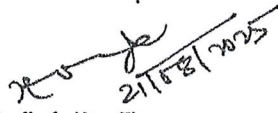

The meeting ended with a vote of thanks to the Chair.

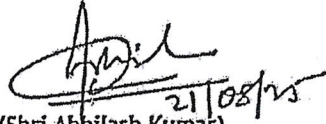
