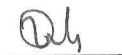
2.1 It is informed that the competent authority has approved entrustment of the subject project stretch to BRO for further implementation henceforth.

4. You are requested to return the duplicate copy of LOA as an acknowledgement and sign the Contract Agreement within the period prescribed in Clause 1.3 of the RFP.

5. You are also requested to furnish Performance Security for an amount of **Rs. 2,57,87,563/- (Rupees Two Crore Fifty-Seven Lakh Eighty-Seven Thousand Five Hundred Sixty-Three Only)** and Additional Performance Security for an amount of **Rs. 5,15,75,127/- (Rupees Five Crore Fifteen Lakh Seventy-Five Thousand One Hundred**



Twenty-Seven Only) as per Clause 2.21 of the RFP within 30 (thirty) days of receipt of this Letter of Acceptance (LOA). In case of delay in submission of Performance Security and Additional Performance Security, if any, you may seek extension of time for a period not exceeding 60 (Sixty) days in accordance with Clause 2.21 of RFP.

6. In case of failure of submission of Performance Security, Additional Performance Security and Security against Damages (if any) within the additional 60 (Sixty) days' time period, the award shall be deemed to be cancelled and Bid security shall be encashed by the Authority as per Clause 2.21 of the RFP.
