

Minutes of the meeting of the Evaluation Committee held on 08.08.2025 for Evaluation of Technical bids for the work of "Emergent Restoration of superstructure and foundation of Gairganda Bridge including protection work at Chainage 2.200 kmp of NH-317 near Birpara, in the district of Alipurduar, West Bengal, during the year 2025-26. (Phase- II) [Job No. RO/KOL/SR/WB/2025-26/01(2)]. [Tender ID: 2025_MoRTH_868544_1]

Sanctioned Cost : Rs.154.79 Lakh. and Cost put to tender: Rs.14270132 Lakh, including 18% GST

Bid Package No. : e-NIB No.06 of 2025-26 of Superintending Engineer, PIU-II, Siliguri.

1. Superintending Engineer, PIU-II, Siliguri, informed that Administrative Approval with Technical and Financial Sanction was accorded by the Ministry vide letter file no. NH-12014/34/2025-RO-KOL dated 28.07.2025 for the above mentioned Restoration work.
2. In light of the approval for the work, on-line bid was invited by the Superintending Engineer, PIU-II, P.W. (Roads) Directorate through the e-tendering portal <https://eprocure.gov.in/eprocure/app> for the subject work under e-NIB No.06 of 2025-26 of Superintending Engineer, PIU-II dated 11.07.2025 under single stage two cover system. After receiving of Bid Security physically as per scheduled date and time, Technical Bid was opened from the web portal: <https://eprocure.gov.in/eprocure/app> on 04.08.2025 after 15:00 hrs in the office of the SE, PIU-II, Siliguri, and it was found that following 2(two) bidders have participated in the bid:
 - (i) Nantu Ghosh, of Mohanta Para, Jalpaiguri, WB.
 - (ii) Nirman & Co (India), Bholardabri, Alipurduar, WB.

As a first step towards evaluation of the Technical Bids, the Evaluation Committee scrutinized the bid documents in accordance to the NIB. The detailed evaluation sheet as per the NIB-06 is placed at Annexure-I.

3. The Superintending Engineer apprised the members of the Evaluation Committee that, both the bidders have duly submitted the cost of bid (Rs. 10,000/-) and the bid security (Rs. 2,14,201/-) in proper form and subsequently the confirmation regarding authenticity of the instruments have also been obtained from the issuing bank respectively.
4. Thus the proposals of the bidder has further been evaluated by the concerned SE, PIU-II based on the requisite documents furnished to substantiate the Technical Capacity in accordance to Clauses 4.3(i), 4.6(i) and 4.6(ii). Mandatory Technical Experience from the Eligible Projects specified in accordance to Clause 4.5.1, Financial Capacity in accordance to clauses 4.6 of the RFP respectively and Bid Capacity in accordance to Clause no. 4.7 of the NIB, on receipt of undertakings as par clause 4.3 (j) & for List of Equipment & Availability of personnel and broad findings are as follows and detailed authenticated Evaluation sheet is annexed:



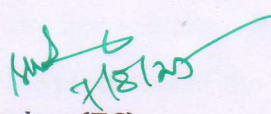

5. Based on the detailed evaluation, the Evaluation Committee recommends following Bidders as "Responsive & Technically Qualified": -

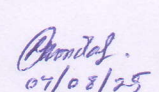

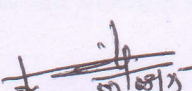
