The bid for carrying out independent Road Safety Audits and prepare estimate for rectification of identified Black spots (1. Chapka, Ghaghra, NH-143A, 2. Bardkadih, NH-143A, 3. Kharkha Pool, NH-143A, 4. Devidhi Lohardaga Road Gumla, NH-143A, 5. Mission Chowk, Lohardaga Road, NH-143A, 6. Khatwa Nadi, NH-143A) was invited vide Tender Ref. no. RW/Ranchi/Road Safety/2025-26/5 on 11.07.2025.

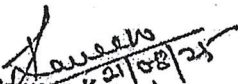

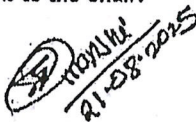

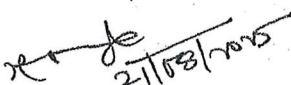

The meeting ended with a vote of thanks to the Chair.

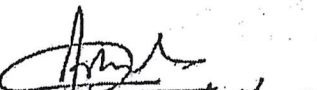
