

Minutes of meeting of Evaluation Committee for evaluation of technical bids for the work " Consultancy services for preparation of DPR for the works of (i) 4L Spur to Khatu from Shahpura (NH-48) in the state of Rajasthan (tentatively 60km) (ii) Bypass/realignment of Alwar, Viratnagar, Naugaon etc. and rectification of accident spots/blackspots on Hanuman circle to Bagad tiraya section of NH-248A (tentatively 25km) (iii) Realignment of Atru town and widening of remaining 2L sections to 2L+PS of Baran -Aklera section of NH-752 (Length -35km tentatively) (iv) Repair and rehabilitation of existing Hameer ROB on NH-552Ext. and existing Amjhar bridge on NH-52 in the State of Rajasthan (length - 1km tentatively) (v) 4 laning from km 0 to km 57 of Fatehpur-Jhunjhunu section of NH-11 (Length - tentatively 57 km) in the State of Rajasthan" held on 07-10-2025 at Regional Office Jaipur.

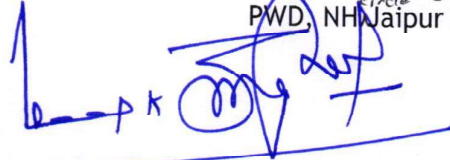
