Minutes of meeting of Bid Evaluation committee held on 27/08/2025 of Technical Bid evaluation for the Work "Construction And Laying Of Boundary Pillars Along Nh 710 (Tarku Damthang Namchi Road, 32.00 Km) & Nh-710 (Melli Manpur Namchi Road, 32.015 Km) In The State Of Sikkim" "under contingency provisions of the work "PBMC works to be taken up along NH-710 Tarku-Damthang-Namchi road km 0+000 to 32+00 and Melli-Manpur-Namchi Road km 0+00 to km 32+200 in the state of Sikkim."

Ministry vide letter no. RW/GHT/DP/SK(O)/2022-23/08/272, dated: 11/07/2025 had accorded Administrative approval and Financial Sanction for the work as stated above amounting to Rs. 36.69 Lakhs. The work is thus proposed under by the state PWD, Government of Sikkim as per Ministry's extant guidelines.

4. Out of the total nos. Of 03 (Three) bids received, the bid submitted by M/S Ugen Tenzing Bhutia and Santosh Pradhan were found Non- Responsive. Details for evaluation of the bid as non responsive is contained in the evaluation sheet enclosed as stated in the previous para. The bid submitted by M/S Toptech Infrastructure is found to be Responsive.
5. Further the BEC was of the view that the procurement of the instant bid satisfied all the relevant conditions laid down at para 4 of the Ministry's extant policy on acceptance of single bid vide circular no: RW/NH-33044/25/2024-S&R(P&B)C No. 240989, dated: 28/08/2024. Hence the BEC recommends opening of the financial bid of M/S Toptech Infrastructure only, on 04/09/2025
