Member Secretary apprised that above mentioned Bids was invited online through Ministry's tender portal on 31.07.2025 NIT No. 01/2025-26 (Superintending Engineer PWD (NH) Circle-Jodhpur) and according tenders were received with last date of submission as . The Bid were opened on 12.08.2025. The Following 04 Nos (four) bidders participated in this tender.

1. M/s J.K.D Construction, Pali
2. M/s Sawariya Construction, Udaipur
3. M/s Shubham Enterprises, Jaipur
4. M/s EQRA International, Udaipur

4. Evaluation Committee examined the relevant documents submitted by bidders & evaluated technical bids & the results of technical Proposal are under as per technical evaluation report:-

4	M/s EQRA International, Udaipur	Non-Responsive	Does not meet the eligibility criteria as stipulated under RFP Clause No. 4.3 B (b) (ii), and has further submitted a fabricated CV of Mr. Vinay Kumar Gehlot (Incident-cum-Road Property Manager-cum-Route Operation Manager)."

5. Furthermore, the Member Secretary informed that after detailed evaluations of bidders, 1 (one) bidder technically responsive, so single bid may be opened after considering the MoRTH guidelines viz. No. E-file No. RW/NH-33044/25/2024-S&R(P&B) (Computer No. 240989) dated 28.08.2024 in which conditions are mentioned as below:-

- i) The procurement was satisfactorily advertised and sufficient time was given for submission of bids.
- ii) The qualification criteria were not unduly restricted: and
- iii) Prices are reasonable in comparison to market value.

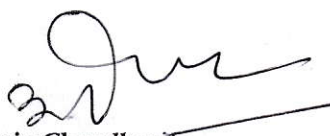
Accordingly, conditions **i & ii** have been satisfied in this bidding process and condition **iii** will check during financial bid evaluation.
