

Minutes of meeting held on dated 13.10.2025 for evaluation of Financial Bids for "Strengthening of stretches of NH-148B (Km 234.900 to Km 244.750 and Km 287.710 to Km 349.640) and NH-703 (Km 182.750 to Km 189.240) in the State of Punjab. Job No.NH-148B &NH-703-PB-2025-26-582"

Sanctioned Cost: Rs. 87.08 Cr.

Amount put to tender: Rs.69.39 Cr. (excluding GST)

Meeting of the Financial Evaluation Committee held on dated 13.10.2025 to finalize the evaluation of the Financial Bids as received from Intended bidders as per the Standard RFP document of the Ministry. The following members of Evaluation Committee were present: -

The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary appraised that the proceedings of the Technical Evaluation Committee held on dated 25.09.2025; out of total Eight (08) bidders, Seven (07) bidders were found responsive and One (01) bidder was found Non-Responsive. It was also decided by the committee on dated 25.09.2025 to open the Financial Bids of following Seven (7) technically responsive bidders on dated 06.10.2025 at 01.00 PM.

3. The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary also informed that summary of Technical evaluation minutes of Technical bid was published on the web portal and no quarry/objection was received from any bidder. It was also decided in the Technical Evaluation Committee held on dated 25.09.2025 that as per clause 2.2.2.1 of RFP, all the responsive bidders shall be directed to furnish the certified updated value of B as on dated 06.10.2025 (duly considering even the works for which bidder has emerged as the winner of the bids, but LOA has not been issued), as per the format stipulated in RFP, positively upto date 06.10.2025 by 11.00 AM through email "ee.nhd1.bti.pwd@punjab.gov.in." Accordingly, the Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary further informed that the updated value of 'B' of all the technically responsive bidders has been received and after examination of 'B value', the following bidders found technically responsive: -

The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary informed that the Financial Bids for the Seven (7) nos. technically responsive bidders were opened through <http://eprocure.gov.in/eprocure/app> in their office on 06.10.2025 after 01.00 PM. The rates quoted by following Technically Responsive Bidders in their Financial Bids have been downloaded from website and the financial position in respect of each bidder is as follows:

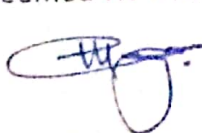
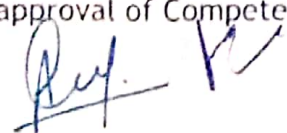

5. The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary has explained the financial position of this project as under: -

A)	RFP Cost	:	₹ 69,38,72,680/- (Excluding GST)
B)	Lowest Bid Cost	:	₹ 40,21,00,000/- (Excluding GST)
C)	Cost below the amount	:	(-) 42.05% Below put to tender

6. The Committee noted that the quoted price of ₹ 40,21,00,000/- (₹ Forty Crore and Twenty One Lakh only) excluding GST by M/s Ramesh Chander Contractor Co. Pvt. Ltd., Sirsa (Haryana) is lowest among all the Seven (7) financial proposals which is -42.05% below the cost put to tender i.e. ₹ 69,38,72,680/- (Excluding GST).

7. Further, the Committee has deliberated the matter related to 3% Performance Security along with the additional Performance Security and has recommended to follow the instructions outlined in Clause 2.21 of ITB of approved RFP and MoRTH, New Delhi Circular No. RW/NH-33044/34/2024-S&R (P&B) (Computer No. 246283) dated 30.04.2025, as deemed fit with the approval of Competent Authority.

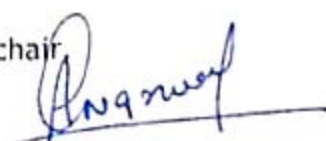
8. The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary informed that as the bid of L-1 bidder was very low (42.05% below from tender cost), so vide their letter No.2984 dated 08.10.2025, a clarification was sought from L-1 bidder for justification of rates for completion of work. The Executive Engineer, National Highway Division No.1, Bathinda -cum- Member Secretary further informed that in response of above letter, the L-1 bidder vide his letter dated 09.10.2025 has assured that their quoted rates are reasonable with a minimal margin of profit. L-1 bidder has mentioned that they have all the relevant and necessary machinery and manpower available, keeping overhead charges minimal. Bidder has also assured to execute work successfully with highest quality and within shortest possible time frame. Accordingly, the Executive Engineer, NH Division No.1, Bathinda and Superintending Engineer, NH Circle, Ferozepur has recommended to award the work to the L-1 bidder at quoted bid price of ₹40,21,00,000/- (₹ Forty Crore and Twenty One Lakh only) excluding GST.

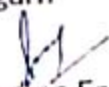
9. The Committee agreed with the recommendation of the Executive Engineer, NH Division No.1, Bathinda and Superintending Engineer, NH Circle, Ferozepur for the award of work to the lowest bidder M/s Ramesh Chander Contractor Co. Pvt. Ltd., Sirsa (Haryana) at quoted bid of ₹40,21,00,000/- (₹ Forty Crore and Twenty One Lakh only) excluding GST, while considering the written clarification dated 09.10.2025 of the L-1 bidder after approval from Competent Authority as per MoRT&H guidelines dated 23.02.2018.
