MINUTES OF THE MEETING OF THE TENDER EVALUATION COMMITTEE HELD ON 25/09/2025 AT 14.30 HRS. FOR FINANCIAL EVALUATION IN THE OFFICE CHAMBER OF THE CHIEF ENGINEER, PWD, MANIPUR FOR CONSIDERATION OF THE BID UNDER NIT NO. CE/NH/NIT/2025-26/16 Dated. 11th August 2025

The work **"Short Term Maintenance to NH-102A from Km 168.210 to Km 202.000 (Length = 33.790 Km) for the year 2025-26 under NH Division No-II in the state of Manipur."** (Job No.:- RW/GHT/NH-102A/MN/STMC/2025-26/04) under consideration was sanctioned by the Ministry of Road Transport & Highways, Regional Office, Guwahati, for an amount of Rs. 3.38 crore vide No. NH-12/17/2025-RO Guwahati (C. No. 256380) dated 27th August, 2025.

2. As the sanction amount is less than Rs. 5.00 crore, the tender was invited by the State PWD using the requisite bidding documents and procedures, in accordance with IRC:SP:124-2019 and the Ministry's specifications for Road and Bridge Works (5th Revision). The compositions of the Tender Evaluation Committee, as constituted vide OM No.18/1/PW-BIDS/2022-23/540 dated 03/09/2025 is as under:

The Bid for the above mentioned work amounting to Rs. 264.35 lakh (excluding 18% GST, but including labour cess of 1%) was invited by Chief Engineer, PWD, Manipur vide NIT No. CE/NH/NIT/2025-26/16 dated 11th August 2025, under the two cover system comprising of "Technical Bid" and "Financial Bid" in accordance with Ministry's extant circular No.RW/NH-24035/4/2008-P &M/PIC dated 21/05/2010. The Technical Bids submitted by the bidders were opened on 02/09/2025 at 14.00 Hrs. in the Office Chamber of The Chief Engineer, PWD, Manipur. A total of 3 (three) Bids were received online. The details of the Bidders are shown in table placed below:

4. The Tender Evaluation Committee examined the Technical Bids of the 3 (three) bidders in its meeting held on 18/09/2025 at 12.00 Hrs. in the Office Chamber of Chief Engineer, PWD, Manipur. All 3 (three) bidders were found to be technically responsive. The minutes of the technical evaluation was uploaded on Central Public Procurement Portal (CPPP) at <https://eprocure.gov.in/eprocure/app> on 19/09/2025. Further, no complaints were received from any of the bidders up to the date of opening of the Financial bids.

The Financial bids were opened on 23.09.2025 at 14.30 Hrs. in the Office Chamber of Chief Engineer, PWD, Manipur in the presence of the bidders/their representatives and members of the Committee who chose to attend. All 3 (three) technically responsive bidders had submitted their Financial bids. The details of the Financial bids quoted by the bidders are as below: -

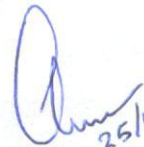

6. In view of the above, the Tender Evaluation Committee recommends that the above work may be awarded to the L-1 bidder, S. Lalmohon Singh, Ngaikhong Siphai Mamang Bishnupur District, Manipur, at his quoted financial bid price of Rs.1,61,25,429.83 (*Rupees one crore six one lakh twenty five thousand four hundred twenty nine and eighty three paise*) only, which is 39.00% below the tender cost of Rs. 2,64,35,130.87 (*Rupees two crore eighty four lakh thirty five thousand one hundred thirty and eighty seven paise*) only, subject to the contractor furnishing the stipulated Performance Security of 5% of the Bid Price, amounting to Rs.8,06,300.00 (*Rupees eight lakh six thousand three hundred*) only, along with Additional Performance Security of 4.80% of the Bid Price, amounting to Rs.7,74,100.00 (*Rupees seven lakh seventy four thousand one hundred*) only. The tender amount is exclusive of GST @ 18%.
