

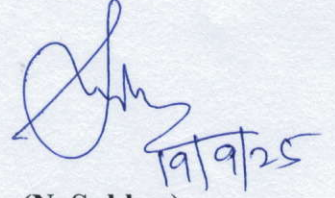

**MINUTES OF THE MEETING OF TECHNICAL EVALUATION COMMITTEE HELD ON
18/09/2025 AT 12:00 HRS FOR TECHNICAL EVALUATION OF BIDS IN THE OFFICE
CHAMBER OF THE CHIEF ENGINEER, PWD, MANIPUR FOR CONSIDERATION OF THE BID
UNDER NIT NO. CE/NH/NIT/2025-26/16 Dated. 11th August 2025**

The work "*Short Term Maintenance to NH-102A from Km 168.210 to Km 202.000 (Length = 33.790 Km) for the year 2025-26 under NH Division No.-II in the state of Manipur.*" (Job No.:- RW/GHT/NH-102A/MN/STMC/2025-26/04) under consideration was sanctioned by Ministry of Road Transport and Highways, Regional Office, Guwahati amounting to Rs. 3.38 crore vide No. NH-12/17/2025-RO Guwahati (C. No. 256380) dt. 27th August, 2025.

2. As the sanction amount is less than Rs. 5.00 crore, the tender is invited by the State PWD using the requisite bidding document and procedure, in accordance with IRC:SP:124-2019 and the Ministry's specifications for Road and Bridge Works (5th Revision). The compositions of the Technical Evaluation Committee vide OM No. 18/1/PW-BIDS/2022-23/540 dt. 03/09/2025 is as under:

The tender for the above mentioned work was invited by Chief Engineer, PWD, Manipur vide NIT No. CE/NH/NIT/2025-26/16 dt. 11th August 2025, under the two cover system comprising of "Technical Bid" and "Financial Bid" as per Ministry extant circular No. RW/NH-24035/4/2008-P &M/PIC dt. 21/05/2010. The sale of Bid Documents through the Central Public Procurement Portal (CPPP) commenced on 12/08/2025, with the bid submission due date fixed on 01/09/2025. The amount put to tender/Estimated project cost (excluding 18% GST, but including labour cess of 1%) is Rs. 264.35 lakhs. The Technical Bids submitted by the bidders were opened on 02/09/2025 at 14.00 hrs in the Office Chamber of The Chief Engineer, PWD, Manipur.

4. A total of 3 (three) Bids were received online on the above mentibned portal, as details in the table below:

5. As per the NIT published by Chief Engineer, PWD, Manipur, dt. 11/08/2025, it was mandatory for the bidders to submit the hard copies of Document Fee, Power of Attorney and Original BG for Earnest Money Deposit etc. before the bid submission deadline. All the bidders have duly submitted the hard copies of the above mentioned documents. Further, the Tender Fee and Original BG for Earnest Money Deposit are in compliance with the provisions of RFP. Accordingly, the committee decided to proceed with the evaluation of the Technical Bids for all the bidders.

6. The genuineness of the Bank Guarantees has been verified by the Beneficiary Bank Branch. Further, the correctness of work completion certificates for similar nature of work, as submitted by the bidders, has been duly verified from the respective issuing offices.

7. Based on the documents placed before the Technical Evaluation Committee, and after due deliberation, the Committee found the Technical Bid of all 3 (three) Bidders to be technically responsive. The detailed evaluation sheet is enclosed herewith as **Annexure-I**.

8. In view of the above, the Technical Evaluation Committee recommends the opening of the Financial Bids of these bidders.



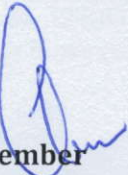

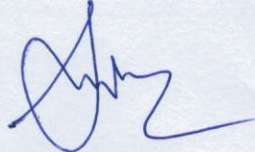
