Bids for the subject work were invited online by the o/o Regional Office, MoRTH, Dehradun on 27.08.2025 as per extant norms. The consultancy work is to be executed by State PWD, Uttarakhand. The Bid due date of subject work was 13.10.2025. Online Bid was opened by tender evaluation committee on 14.10.2025. Earlier in meeting held on 24.12.2025 & 13.01.2026 Out of 17 bidders, 14 bidders were found technically responsive. The MOM of Technical evaluation is enclosed as Annexure A & B. The result of technical evaluation was uploaded on e-procurement portal.

2. It was apprised by the Member Secretary that M/s Technocrats Advisory Services Private Limited (M/s TASPL) had been debarred by NHIDCL vide letter No. NHIDCL/Tripura/BM-BRT/TASPL/2017/1896 dated 02.01.2026. Accordingly, M/s Technocrats Advisory Services Private Limited (M/s TASPL) was considered non-responsive as per the Ministry's circular dated 04.01.2022 during the meeting held on 13.01.2026.

However, M/s Technocrats Advisory Services Private Limited (M/s TASPL), vide letter dated 15.01.2026, represented that the said debarment order had been stayed by the Hon'ble High Court vide order dated 12.01.2026, whereby it was specifically directed that, till the next date of hearing, the operation of the debarment order dated 02.01.2026 shall remain stayed.

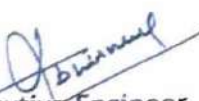
The matter was deliberated, and it was observed that as on the bid due date, M/s Technocrats Advisory Services Private Limited (M/s TASPL) was not debarred, and as on date also, the debarment order stands stayed. Accordingly, the bid may be considered responsive as per the RFP. The same was agreed by the Committee.

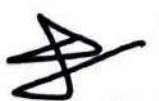
