The work "*Special Repair (SR) work on NH-102A, Shangshak-Tengnoupal Section in the State of Manipur for the year 2025-26. (SH: Restoration and Realignment works by hill cutting and new road formation starting from ch. km 69.915 for a length of 200.00m including GSB, WMM, Open-Graded Premix Carpet (PC), and Seal Coat).*" (Job No.:- 102A/MN/2025-26/43) under consideration was sanctioned by Ministry of Road Transport and Highways, New Delhi- 110001 amounting to Rs. 77.56 lakh vide No. NH-12014/209/2025/MN/Zone-NE (C. No. 258056) dt. 18th September, 2025.

2. As the sanction amount is less than Rs. 5.00 crore, the tender is invited by the State PWD using the requisite bidding document and procedure, in accordance with IRC:SP:124-2019 and the Ministry's specifications for Road and Bridge Works (5th Revision). The compositions of the Technical Evaluation Committee vide OM No. 18/1/PW-BIDS/2022-23/540 dt. 03/09/2025 is as under:

The tender for the above mentioned work was invited by Chief Engineer, PWD, Manipur vide BID No. CE/NH/BID/2025-26/02 dt. 1st September 2025, under the two cover system comprising of "Technical Bid" and "Financial Bid" as per Ministry extant circular No. RW/NH-24035/4/2008-P &M/PIC dt. 21/05/2010. The sale of Bid Documents through the Central Public Procurement Portal (CPPP) commenced on 02/09/2025, with the bid submission due date fixed on 09/09/2025. The amount put to tender/Estimated project cost (excluding 18% GST, but including labour cess of 1%) is Rs. 60.59 lakh. The Technical Bids submitted by the bidders were opened on 10/09/2025 at 14.00 hrs in the Office Chamber of The Chief Engineer, PWD, Manipur.

4. A total of 2 (two) Bids were received online on the above mentioned portal, as details in the table below:

5. As per the NIT published on 01/09/2025, it was mandatory for the bidders to submit the hard copies of Document Fee, Power of Attorney and Original BG for Earnest Money Deposit etc. before the bid submission deadline. All the bidders have duly submitted the hard copies of the above mentioned documents. Further, the Tender Fee and Original BG for Earnest Money Deposit are in compliance with the provisions of RFP. Accordingly, the committee decided to proceed with the evaluation of the Technical Bids for all the bidders.

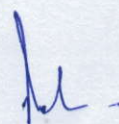

7. Based on the documents placed before the Evaluation Committee, and after due deliberation, the Committee found the Technical Bid of all 2 (two) Bidders to be technically responsive. The detailed evaluation sheet is enclosed herewith as **Annexure-I**.

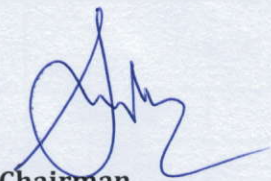
