

Minutes of meeting of Evaluation committee held on 18.03.2026 @12:30 Hrs. through hybrid mode for the work " Consultancy Services for Authority's Engineer for supervision of Rehabilitation and up-gradation to 2-lane configuration of NH309A from km 103.25 (Kanda) to Km 122.72 (Bageshwar)(Existing Km 110 to Km 130) in the State of Uttarakhand (Package-II)".

Bids for the subject work were invited online by the o/o Regional Office, MoRTH, Dehradun on 03.09.2025 as per extant norms. The consultancy work is to be executed by State PWD, Uttarakhand. The Bid due date of subject work was 31.10.2025. Online Bid was opened by tender evaluation committee on 06.11.2025. Earlier in meeting held on 24.02.2026 Out of 15 bidders, 14 bidders were found technically responsive. The MOM of Technical evaluation is enclosed as Annexure A. The result of technical evaluation was uploaded on e-procurement portal.

2. It was apprised that representation of 05 bidders on the technical evaluation have been received. 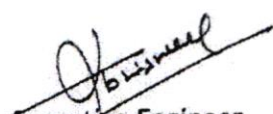

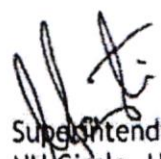

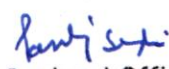
5. The revised result was concurred by all the Committee members. Further Committee recommended to open Financial bid of responsive bidders.
