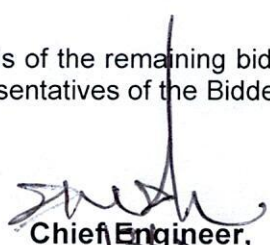
The Authority may open the online Financial Bids of the bidders only on schedule date and time in the presence of the authorized representatives of the Bidders, who may choose to attend.

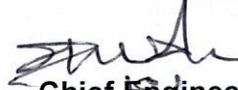
