As per the Minutes of meeting held on 03.12.2025, the Evaluation Committee had recommended to open the financial bids of the technically responsive bidder. The result of technical evaluation was displayed on e-procurement portal on 12.12.2025 for 07 days as per RFP Clause 23.5& no representation was received from any of the bidders.

2. Accordingly, the financial bids of eligible bidder were opened on 20.12.2025 at 11:00 hrs. The details of financial quotes submitted by the eligible bidders are as under:

3. Based on the amount quoted by the bidder, the price bid of M/s GRRB Associates is found to be the lowest (L1) which is 0.51% below the estimated cost put to tender

In view of the above, the Evaluation Committee accepts the price quoted by the L1 bidder and recommended to award the work "Performance Based Maintenance Contract (PBMC) on Jairampur - Pangsau-pass Road section of NH-315 from Km 24.000 to Km 56.485 during the year 2025-26 in the state of Arunachal Pradesh" to the selected bidder M/s GRRB Associates at the quoted bid price of Rs. 29,13,95,893/- (Rupees Twenty Nine Crore Thirteen Lakh Ninety Five Thousand Eight Hundred Ninety Three only) subject to submission of performance security in the form set forth in SECTION-4 of RFP for an amount of Rs. 87,41,877/- (Rupees Eighty Seven Lakh Forty One Thousand Eight Hundred Seventy Seven only) as per Clause-32 of the RFP.
