The evaluation committee considered the documents uploaded by bidders as well as provided by them in original and it was noticed that Class B & C contractors are eligible for this tender, but two Class-A Contractors namely M/S Om Parkash Sharma & Sons Class A Contractor, Daulatpur Chowk Distt Una & M/S G.P. Acharya Const. Pvt. Ltd. Class A Contractor VPO Sagoor, Tehsil Baijnath, Distt Kangra have participated in this tender.

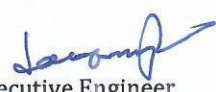
After deliberations, the committee decided not to consider the bids of above two Class A Contractors. The bid of third bidder i.e. M/S Sanjay Thakur Class B Contractor Village Rohalwin, Tehsil & Distt Hamirpur will remain single now. The single bid is not acceptable in first call, so committee recommends not to proceed further with this tender and decided to cancel this tender and re-tender the same.
