Meeting of Evaluation Committee for the evaluation of Financial Bids held under the Chairmanship of The CE (NH) PWD Rajasthan Jaipur on dated 30.01.2026 at 04:00 PM for the work of **“Balance work of widening to four lane with paved shoulder from km 166.00 to 172.200 on Old NH-89 (left out one time improvement) at Nagaur city in the State of Rajasthan on EPC Mode”**.

Sanctioned Cost :- Rs. 29.77 Crore (Amount put to tender Rs. 27.90 Crore)

- I. At the outset the Chief Engineer (NH) PWD Raj., Jaipur welcomed the participants. It was apprised by SE (NH) PWD, Circle-Bikaner that the Technical Bid Evaluation Committee meeting was held on dated 20.01.2026 & approved the eligibility of 1 No. (One) bidder after evaluation of the technical bids received from bidders. Minutes of the meeting are enclosed.
- II. Financial Bid of the 1 No. (One) eligible bidder was opened on CPPP portal on dated 27.01.2026 and the relevant documents downloaded from the portal & same are enclosed. The details of financial bids received are as under:-

- III. The Evaluation Committee evaluated the financial bids during its meeting held on dated 30.01.2026 it is observed by the evaluation committee that the lowest tendered amount of Rs. 29,97,48,001/- (Rs. Twenty Nine Crore Ninety Seven Lakhs Forty Eight Thousands and One only) quoted by M/s MDB Project Pvt. Ltd., Shiv Shakti Vihar, Jaipur Road, Bikaner which is 7.45% Above on sanctioned civil work cost (based on PWD NH Circle Bikaner BSR-2024).
- IV. After detailed deliberation, the Evaluation Committee found that the lowest bid rates are on higher side with respect to prevailing rates in other contracts of similar nature of works. Hence the Committee decided to reject the bid and re-invite afresh tender.
