The work has been sanctioned by the MoRTH vide letter No. NH-120137/51/2025/HP/North-I (comp no. - 250008) dated 11.08.2025 for Rs. 1,77,40,813/- and the bids for the said work were invited on the basis of approved civil cost of Rs. 1,38,60,010/- (excluding GST) as per Technical note dated 25.08.2025 received from the RO MoRTH. 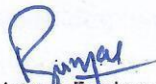

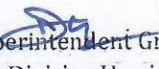
