**Name of the Work: "One time improvement: Electrical pole & Street Lightings from Railway
over Bridge (ROB-18) to Sri Nanjundeshwara Temple on NH-150A in Nanjangud Town"**

Preamble

The Secretary to Government of Karnataka, Public Works Department, Vikasa Soudha, Bangalore vide letter No. 1052/ಎಎಫ್‌ಎ/2025(ಇ-ಕಚೇರಿ) dated :24.12.2025 has accorded financial allocation of Rs. 70.00 Lakhs for the work of One time improvement: Electrical pole & Street Lightings from Railway over Bridge (ROB-18) to Sri Nanjundeshwara Temple on NH-150A in Nanjangud Town. Accordingly, the Executive Engineer, National Highways Division, Bangalore has prepared an estimate based on the National Highway Schedule of Rates 2022-23 continued for the year 2025-26 amounting to Rs. 70.00 Lakhs.

Administrative approval and Technical Sanction is accorded by central office assigning the sanction No. CER No. 06/2025-26, dated 24.12.2025 for an amount of Rs. 70.00 Lakhs.

Tender was called for the said work vide Notification No. 10/2025-26 dated 30.12.2025 through e-portal <https://eprocure.gov.in> by the Executive Engineer, NH Division, Bangalore. Amount put to tender is Rs. 58.61 Lakhs (excluding GST) and the calendar of events were as under:

1. Request of Tender Document From : 30.12.2025 at 11.00 Hrs
2. Request of Tender Document To : 12.01.2026 at 16.00 Hrs
3. Tender closing Date and Time : 12.01.2026 at 16.30 Hrs
4. Technical bid open Date & Time : 13.01.2026 at 16.00 Hrs
5. Time & Date of opening of Financial bid : After approval of Technical Bid

The Technical Bids were opened on 13.01.2026, in response and 2 bidders have participated in the tender. The following 2 bidders have submitted original EMD & LOC within the stipulated date and time of opening of tender as specified in the Notice Inviting Tender. The bidder's documents were downloaded and considered for evaluation:

1. Sri. Sri Ramesh M H Mysore

2. Sri Ashoka S Mysore.

The meeting of the Technical Bid Evaluation Committee constituted vide letter dated 31.12.2025 was convened on 19.01.2026 in the chambers of the SE, NHC, Bangalore to evaluate the technical bids received for the above said work, comprising the following members:

The technical bid documents substantiating the qualification criteria indicated in the KW-3 were verified and the committee has resolved the qualification criteria of bidders as under:

TECHNICAL EVALUATION

1. Sri. Sri Ramesh M H Mysore

It has been noticed that bidder has submitted (1) the bid security, 2) Annual turnover report as per Clause 3.2 (a), 3) Work done certificate as a single prime contractor as per clause 3.2(b) and 4) bankers certificates for credit facilities as per clause 3.3b.

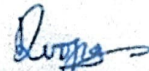

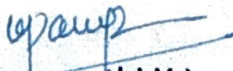

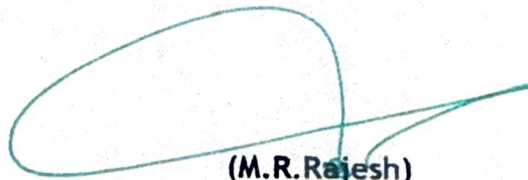
