The tender for the work of "Supply and erection of High mast lights along with all accessories at Km 6+000, Km 10+700 and Km 57+235 of Nagapattinam - Thanjavur section of NH-67 (New NH-83) in the State of Tamil Nadu on item rate basis (3rd call)" (Tender ID: 2025_NHAI_223191_3) was invited on 29.04.2025 under Two Cover System by the Manager (Tech), NHAI, PIU Thanjavur through online and last date for submission of bid was fixed as 13.05.2025. The technical bids were opened on 14.05.2025.

3. The accepted technical bids were evaluated by the evaluation committee and the technical bids of the following 2 bidders were found as "Responsive":

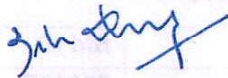
4. Further, the financial bids of the above responsive bidders were opened on 02.06.2025. The Composition of the Financial Evaluation Committee is the same as Technical Evaluation Committee. The aforesaid evaluation committee has evaluated the financial bids on 03.06.2025.

5. After Evaluating the Financial bids, the committee found that the bid of **M/s. Schnell Energy Equipments Pvt Ltd., Coimbatore (Bid ID: 850107)** to Rs.13,67,947/- working out to 8.36% lower than the amount put to tender i.e., Rs.14,92,740/-.

6. Therefore, the Financial Evaluation Committee decided to recommend the lowest and Responsive bid of **M/s. Schnell Energy Equipments Pvt Ltd., Coimbatore (Bid ID: 850107)** for approval.



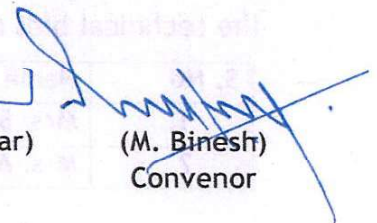
