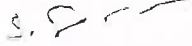

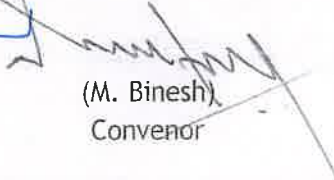
4. The bids received through online are decrypted and evaluated as per qualification criteria set forth in RFP documents. The detailed technical evaluation is attached herewith as Annexure.
