With reference to the subject tender, it is to inform that, the EMD/Bid Security in the form of Insurance Surety Bond submitted by the Bidder, **M/s DMR Builders Pvt. Ltd., Punjab (Bid ID: 815884)** was not confirmed by Finance Division, NHAI, HQ at the time of Detailed Technical Evaluation. However, based on the request received from the said bidder vide letter no.DMR-CHD/2025/1205 dated 05.03.2025, the tender committee has been clarified by Finance Division, NHAI, HQ as due to technical issue with the series, which resulted in the bond not being available on the Portal at that time and as of now, the same Insurance Surety Bond is available on Bajaj Udhyan Sewa Portal.

2) In this connection, by considering the request received from **M/s DMR Builders Pvt. Ltd., Punjab (Bid ID: 815884)**, upon confirmation of Bid Security received from the Finance Division of NHAI, HQ, the Technical Evaluation Results uploaded vide Minutes of Meeting dated 04.03.2025 in the CPP Portal for the subject Blackspot tender (Tender ID: 2025_NHAI 223398_1) is hereby revoked.

3) Accordingly, the technical bid submitted by **M/s DMR Builders Pvt. Ltd., Punjab (Bid ID: 815884)** will be admitted for Detailed Technical Evaluation of the subject Blackspot tender for further course of action.
