

NOTICE INVITING TENDER
(Invitation for RFP)

National Highways Authority of India (the “Authority”) is engaged in the development and maintenance of National Highways and as part of this endeavor, “Independent Engineer Services for Construction of STRR (West side) NH948A Kunigal (Ramanagara Taluk) to S. Mudugadapalli (Hosur Taluk) from Km 79 to km 144.25/144.00 (Design Chainage) Phase-II in Karnataka on HAM (Project Length – 65.25 kms)” is being developed by the Authority. Accordingly, Authority has decided to procure Consultancy Services for appointment of Independent Engineer. Brief particulars of the project are as follows:
