Minutes of Tender committee Meeting for technical evaluation of the tender for Name of Work: Repair & Maintenance of existing road from Km 81/200 - 153/000 of NH-208 (New NH-744) in the state of Tamilnadu (Tender Ref no.: NHAI/PIU/NGL/NH-744/2024/05).

1. NHAI, PIU-Nagercoil invited bids vide Tender ID: 2024_NHAI_187484_3 for the works of *"Name of Work: Repair & Maintenance of existing road from Km 81/200 - 153/000 of NH-208 (New NH-744) in the state of Tamilnadu"* with an estimated cost of Rs.67.19 Lakh (excluding GST and Labour welfare cess).
2. A committee has been constituted with the following members to carry out tender evaluation;
 1. Shri. T. Velraj, Project Director, PIU-Nagercoil
 2. Shri. R. Murugaprakash, DGM(T), RO Madurai
 3. Shri. Manas Chakrabarty, Asst. Manager (F&A), F&A Unit, Madurai
3. Last Date of submission of bids and technical bid opening was scheduled on 25th and 27th January 2025 respectively.
4. As per MoRTH Circular No.RW/NH-37010/4/2010-EAP (Printing) Vol.IV Dated 30.04.2020, evaluation of bids has been carried out with the available documents uploaded in the portal as per RFP requirement.
5. Accordingly, the Committee have opened the e-bids submitted through online and decrypted. Two bids have been received through online from the bidders, 1) M/s. RAM Constructions, Rajapalayam 2) M/s. V. Ravichandran, Kadayanallur.
6. The bids received from the above bidders have been evaluated and the detailed evaluation has been attached in Annexure. As per the evaluation, both the bidders, i.e.1) M/s. RAM Constructions, Rajapalayam (Bid ID: 811138) 2) M/s. V. Ravichandran, Kadayanallur (Bid ID: 810973) have not qualified in the technical evaluation since both the bidders have not submitted the Certificate from the Chartered Accountant as a proof of Turnover for last 3 years not submitted litigation history as per clause 4.2 (f) & (j) of ITB (Section II) of RFP.
7. In view of the above, the Tender Evaluation Committee unanimously decided to annul the bidding process and call fresh tender as per clause 23 of ITB (Section II) of RFP.
