7. In view of the above, committee after due deliberations recommends as under:

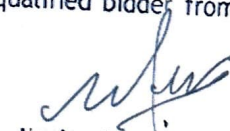
- All two (02) bidders as mentioned in para-6 above, is qualified for opening of their financial bids.
