This has reference to your technical and financial proposal submitted on 26.03.2025 for the above-mentioned project.

2. The Competent Authority has accepted your quoted financial proposal for a contract price of **Rs 5,60,00,000 /-** (Rupees Five Crore Sixty Lakh Only) excluding GST.
3. The above contract price is exclusive of GST but inclusive of all taxes, duties, fees, levies and other imposition as may be levied under the Applicable law and NHAI shall deduct taxes as applicable, out of the eligible payments to be made to the Consultant. The amount towards GST shall be paid by NHAI separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities by the consultant.

It is also requested to furnish within 15 days of issue this Letter of Award (LoA), an unconditional Bank Guarantee from Nationalized Bank as per details mentioned in RFP for an amount equivalent to 10% of the Total Contract Value i.e., **Rs. 56,00,000 (Rupees Fifty-Six Lakh only)** towards Performance Security. This Bank Guarantee shall be as per the format given in the RFP. The Performance Security shall be valid for a period of 50 months i.e., up to 2 months beyond the expiry of the Contract period of 48 months and shall be in the format specified in RFP.

5. You are also requested to conduct the interview of all key personnel as per clause 5.10 of section -2 of RFP. Accordingly, the reduction in remuneration after interview of key personnel will be applicable on the above quoted amount in accordance with RFP.

6. You are required to comply with all the terms and conditions set forth in the RFP documents and subsequent addendums/corrigendum issued. In case of any default on your part, you shall be liable for action as stated in the RFP document.
