The tender for the work of "Reconstruction of Box Culvert at Km 2+975 RHS in Vikravandi - Sethiyathope Section from Km 0+000 to Km 65.960 of NH 36 (Old NH-45C) in the State of Tamil Nadu on item rate basis" (Tender ID: 2025\_NHAI\_226542\_2) was invited on 11.03.2025 under Two Cover System by the Project director, NHAI, PIU Thanjavur through online and last date for submission of bid was fixed as 08.04.2025. The technical bids were opened on 09.04.2025.

3. The accepted technical bids were evaluated by the evaluation committee and the technical bids of the following 3 bidders were found as "Responsive":

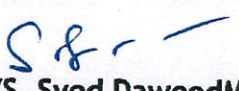

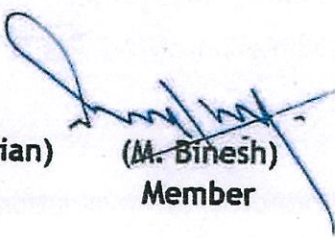
The details of the financial bids are as detailed below:

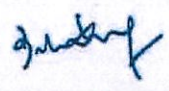

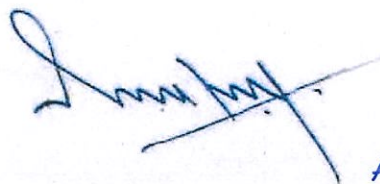

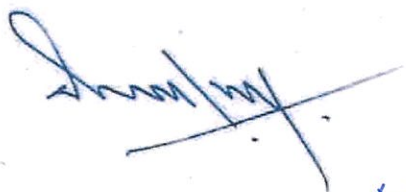
