The bids of the subject project were opened on 11.03.2025 wherein total 6 bidders have participated in the bidding process.

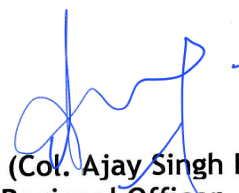
