3. Detailed Comparative Statement for the '**financial evaluation**' (as compiled by this Committee) is placed below at **F/A**, which is summarized as follows:

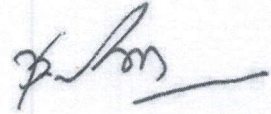
