This has reference to RFP invited for above subject consultancy work dated 23.04.2025. The result of Technical Evaluation after considering representations received from the bidders is as tabulated below:

The other partner has claimed a total of 14 projects under the eligibility criteria requiring <i>experience in the preparation of Detailed Project Reports (DPR) or Feasibility Studies for two/four/six-lane projects</i>, with an aggregate length equal to the indicative package length (e.g., 100 km). Additionally, the bidder was required to have prepared at least one DPR for a project of minimum 40% of the indicative length (i.e., 40 km) or a Feasibility Study of minimum 60% of the indicative length (i.e., 60 km). Upon evaluation of the experience certificates, it is submitted that: (i) The certificate dated 12.05.2023 clearly reflects that the mentioned completion date, 24.06.2023, corresponds to the scheduled completion date as per contract, not the actual completion date. (ii) None of the submitted certificates specify the actual date of completion of the DPR consultancy services. (iii) Furthermore, the certificates do not confirm the completion of the full scope of services as required for DPR preparation. Therefore, the claimed projects cannot be treated as completed assignments.	

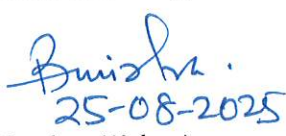

		(iv) As per Form T-11 of the RFP, only Completed Lengths (CL) related to National Highways or Expressways are to be considered for eligibility. However, in the experience certificate submitted for the firm M/s KOBA, no projects related to National Highways or Expressways have been mentioned. The certificates only pertain to State Highway (SH) projects, which do not meet the specified requirement. Hence, the other partner fails to meet at least 50% of the minimum eligibility requirement as mandated for the other partner in a Joint Venture. In view of the above observations, the bid is considered non-responsive.
