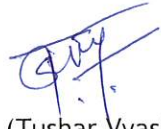

Bidder has claimed Project "Widening and Strengthening of Two - Lane Chakki - Banikhet - Chamba - Bhamour Road NH-154A Km. 93 to 106 in the state of HP on EPC Mode" in its Eligible projects. In the project Bidder has claimed a receipt of Rs. 45.36 Crore. However, as per Subcontracting Agreement submitted Bidder has been approved for Maximum 49% of the cited work and as per the LOA issued to the main contractor i.e. M/s Royal Deep Construction Pvt. Ltd., the cost of the project is Rs. 49.33 Crore. Therefore, as per the Sub-Contracting Agreement Bidder is entitled for work of only 49% of Rs. 49.33 Crore.</p> <p>A Clarification was asked from the bidder in this regard.</p> <p>bidder has not given any justification and submitted the same documents again with some attachment of the financial statements reflecting receipts from the EPC contractor. Which can not be considered as per the Sub-Contracting Agreement wherein Bidder is entitled for work of only 49% of Rs. 49.33 Crore.</p> <p>Hence, only 49% of the claimed amount for the project code "C" has been considered in the evaluation.</p> <p>Accordingly, Bidder is not meeting the requirement of Minimum Threshold Technical capacity as required under clause 4.3 (i) of section 2 of ITB.</p> |

Bidder has Proposed Mr. Rahul Singh Gurjar for the position of Site Engineer-cum-Surveyor Engineer cum Material Engineer. From the available CV it is noted that Proposed CV is not having experience of 4 years on Highway Construction/Maintenance work which is required as per clause 4.1 j (2).</p> |
