3. The details of deliberation of the Evaluation Committee are as under:-

1. M/s SRI TARALABALLU PROVISION STORE AND HOTEL:-

a. **M/s SRI TARALABALLU PROVISION STORE AND HOTEL** has submitted a **new Food License** valid from **13.05.2025 to 12.05.2026**. However, as per **RFP Clause (viii)**, the bidder is required to confirmation turnover in the **relevant field**, supported by valid certification—such as a **Food License**—for the **last two years**. The bidder has not submitted a Food License covering this two-year period, which is necessary to establish experience and operation in the relevant field. As per RFP Clause (ix), the Annual Turnover for the last two years, along with relevant documents, must be certified by a Chartered Accountant and submitted as part of the technical bid. However, the bidder has not submitted the turnover certificate, as required. Whereas submitted Certificate is of Auditor & Tax Coordinator. Hence, the bidder **M/s SRI TARALABALLU PROVISION STORE AND HOTEL** was recommended as non-responsive.

2. M/s S K Enterprises

a. M/s S K Enterprises has submitted a Food License valid from 10.03.2023 to 11.03.2028. However, as per RFP Clause (viii), the bidder is required to confirm their turnover in the relevant field, supported by valid certification—such as a Food License—for the last two years, in order to establish experience and operations in the relevant domain. While the financial year turnover for the period 2022-23 has been submitted, the Food License provided does not cover the entire two-year period preceding the current bid. Hence, the bidder M/s S K Enterprises was recommended as technically non-responsive.

3. All the remaining bidders meet the requirement as stipulated in RFP Hence, their bids have been considered as technically responsive. The details of technical evaluation are tabulated under Annexure-I.
