2. After approval of Competent Authority, the result of technical evaluation was communicated to the bidders vide this office order dated 21.05.2025 & uploaded on e-portal. The financial opening of e-bid for the responsive bidder was scheduled on 23.05.2025 at 13:00 Hrs.

3. The financial bid of technically responsive bidder was opened by the available committee members. The summary of quoted rent offered by the bidders in 2nd call is mentioned below:

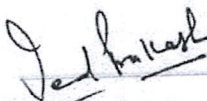
| Sl. No. | Bidder            | Bidder Quoted Rent Per Month (in Rs.) | Remark |

| 1       | Rajesh Vishnoi    | 30,000                                | L1     |
| 2       | Mohan lal Vishnoi | 39,000                                | L2     |

4. The bidder "Mr. Rajesh Vishnoi " has quoted rate as Rs. 30,000/- per month and Mr. Mohan lal Vishnoi has quoted rate as Rs. 39,000/- per month inclusive of services of Society Charges, Parking Charges, Taxes etc.

However, the L1 Bid came out to Rs. 30,000/- which is as per monthly rental ceiling limit of PIU. Further, it is to be mention as per NHAI vide policy circular dated 26.03.2024. the monthly rental ceiling for PIU is  $2500 \times 12 = 30,000$ .

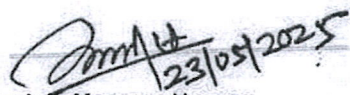
5. Keeping in view of the delegation of power to RO committee recommends to award the subject work after the approval of RO-Bhopal.
