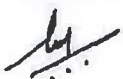


**NATIONAL HIGHWAYS AUTHORITY OF INDIA

Minutes of Tender committee Meeting for technical evaluation of the Tender for sale of standing Trees falling within the ROW of Four laning of Rajapalayam to Sengottai section of from Km 71.600 to Km 139.900 (New NH-744) in the state of Tamilnadu (Tender Ref no.: NHAI/PIU/NGL/NH-744/2025/05) - 2nd Call.

1. NHAI, PIU-Nagercoil invited bids vide Tender ID: 2024_NHAI_234718_1 for the works of "Name of Work: Tender for sale of standing Trees falling within the ROW of Four laning of Rajapalayam to Sengottai section of from Km 71.600 to Km 139.900 (New NH-744) in the state of Tamilnadu" with an estimated cost of Rs.1.89 Crore.
2. A committee has been constituted with the following members to carry out tender evaluation;
 1. Shri. T. Velraj, Project Director, PIU-Nagercoil
 2. Shri. K. Murugan, Joint Advisor (Env. & Plantation), RO-Madurai
 3. Shri. R. Murugaprakash, DGM(T), RO Madurai
 4. Shri. Gyan Lilhare, Asst. Manager (F&A), PIU-Nagercoil
3. Bids invited on 08.05.2025 by giving 15 days time and the last Date of submission of bids was scheduled as 23.05.2025 and technical bid opening proposed on 24.05.2025.
4. The Committee have opened the e-bids submitted through online and decrypted. Two bids have been received through online from the bidders, 1) M/s. P.Vijayabalan Works Contract, Vk Pudur 2) M/s Kuttyraja Contractor, Shenkottai. On the technical evaluation, it is observed that the bidder M/s. Kuttyraja Contractor, Shenkottai has not submitted the Certificate from the Chartered Accountant as a proof of Turnover for last 3 years not submitted as per terms and condition point no.9 of RFP, the same is found as non-responsive. Since only single responsive bid is received, the Tender Evaluation Committee unanimously decided to annul the bidding process and call fresh tender.
6. Accordingly, 2nd call for the above bid (Tender ID: 2024_NHAI_234718_2) has been called on 29.05.2025 with 7 days period and last date for bid submission as 05.06.2025 @ 11.00 Hrs and bid opening proposed as 06.06.2025 @ 11.00 Hrs.
7. As per MoRTH Circular No.RW/NH-37010/4/2010-EAP (Printing) Vol.IV Dated 24.05.2025, evaluation of bids has been carried out with the available documents uploaded in the portal as per RFP requirement.
8. The Committee have opened the e-bids submitted through online and decrypted. Two bids have been received through online from the bidders, 1) M/s. P. Vijayabalan Works Contract, VK Pudur (Bid ID: 857898) 2) M/s Chinnathambi, Govt. Contractor, Tenkasi (Bid ID: 858339).



9. On the technical evaluation, both the bidders have qualified in the technical evaluation since both the bidders have furnished all the mandatory documents in line with the RFP. Detailed evaluation has been attached in Annexure.

10. In view of the above, since both the bidders have qualified in the technical evaluation, the Tender Evaluation Committee unanimously decided to open the financial bid of both the bidders in line with RFP.
