Minutes of Meeting of Tender Evaluation Committee (Financial Evaluation) dated 09.07.2025 for the work of "Providing High Mast Lights and Solar Blinkers at various locations identified in Third Party Road Safety Audit in the Karaikudi - Ramanathapuram Section of NH-210 (New NH No.536) in the State of Tamil Nadu on Item Rate Basis (2nd Call)" (Tender Ref. No. NHAI/KKDI/Tender/K-R/RSA/001).

1. The committee evaluated the technical bid and recommended the following;

2. Subsequent to the approval of the Competent Authority, the technical evaluation Minutes were uploaded in the Government CPP Portal on 08.07.2025.

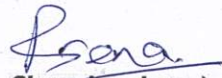
3. Consequently, the financial bid submitted by the aforesaid technically qualified bidder has been decrypted on 09.07.2025 and the amounts quoted by them and the percentage below or above w.r.t. value put to tender (Rs. 54,57,900/-) are as under;

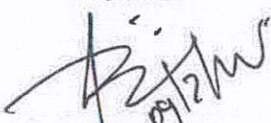

4. Upon noticing the quoted rate, M/s. B. Murugan Engineering Contractor, Madurai (L-1 Bidder) has quoted 1.00% below the estimated amount.

5. In this regard, the committee observed that, the tender has been invited under the second call and sufficient time has already been provided for participation and considering that the current tender involves rectification of a road safety work, which needs to be executed on an urgent basis to prevent accidents and to avoid time overruns. In road safety meeting by the District Administration, it has been frequently insisted to provide necessary safety measures/provisions immediately, to ensure the safety of road users.

6. Also, the bidder has quoted an amount of 1.00% below the estimated rate which is found to be reasonable and to avoid frequent accident and public criticism the committee has unanimously agreed that the amount Rs.54,03,321/- i.e. 1.00% below the estimated amount by the successful bidder deemed reasonable and the single bid may be accepted as per NHAI Circular No.18.78/2022, dated 18.02.2022.
