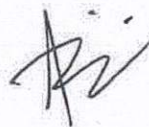
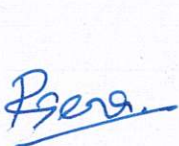

2. The tender for the work of “Providing High Mast Lights and Solar Blinkers at various locations identified in Third Party Road Safety Audit in the Karaikudi - Ramanathapuram Section of NH-210 (New NH No.536) in the State of Tamil Nadu on Item Rate Basis (Tender Ref. No. NHAI/KKDI/Tender/K-R/RSA/001)- 2nd Call” was invited on 06.06.2025 under Two Cover System by the Project Director, NHAI, PIU Karaikudi through online and last date for submission of bid was 18.06.2025. The date of opening of technical bids was 19.06.2025.

3. Accordingly, the tenders received through online were opened by the Evaluation Committee on 19.06.2025. The details of bidders who submitted the bids through online form in e-tender portal are as under:

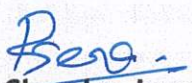
4. The bid received through online is decrypted and evaluated as per the qualification criteria set forth in the RFP documents. The detailed technical evaluation is attached herewith as Annexure-A.



5. In this regard, with respect to the Bid received from (i) **M/s. P&B Enterprises, Erode**, the bidder has not submitted the necessary documentary evidence for the Excavator, either owned/leased/rented as per the requirements mentioned in the Appendix to ITB of RFP, the bidder has not furnished a Power of Attorney as per Clause 12.2 (d) of Section II ITB of RFP and the bidder has furnished a Certificate for Technical Personnel not eligible as per Clause 4.4. B (b)(ii) of Section-II ITB of RFB. As such, as per Clause 12.2 (d) of Section-II ITB of RFP, Clause 4.4. B (b) (i & ii) of Section-II ITB, the Tender Evaluation Committee recommends to consider the bid as **"Disqualified"**.

6. With regards to the Bid received from (ii) **M/s. Schnell Energy Equipment, Coimbatore**, the bidder has not submitted the necessary documentary evidence for the Excavator, either owned/leased/rented as per the requirements mentioned in the Appendix to ITB of RFP and the bidder has furnished a Certificate for Technical Personnel not eligible as per Clause 4.4. B (b)(ii) of Section-II ITB of RFB. As such, as per Clause 4.4. B (b) (i & ii) of Section-II ITB & Clause 4.2 (e) of Section-II ITB of RFP, the Tender Evaluation Committee recommends to consider the bid as **"Disqualified"**.

7. As the above tender invitation is the 2nd call and the bidder has met all the technical qualification criteria and to avoid delay of execution of Road Safety Audit observations rectifications work, the tender committee has unanimously decided to accept the single qualified bid and decided to meet on 09.07.2025 at 15:00 Hrs for opening of the financial bid of the qualified bidder.

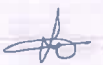
