Annex-A

Reasons for Technical Non-Responsiveness of the bidders:

1. **M/s MBL Infrastructure Limited:-** The Bidder fails to meet the minimum eligibility criteria of Clause 2.2.2.2(i) and 2.2.2.2 (iii) of RFP. Hence, the bidder is Non-Responsive.
2. **M/s Maruti Infracreation Private Limited:-** Bidder fails to meet the minimum eligibility criteria of Clause 2.2.2.2 (iii) of RFP.

The Bidder is declared technically non-responsive and is ineligible for next stage of bidding process on account of Bidder as claimed project namely, Construction of Underpass at Ahmedabad - Mehsana - Palanpur road (SH-41), the 50m length pertains to barrel length of the underpass and 24 m span of the said box (twin box) **does not fulfil the required eligibility criteria (i.e. having the experience of span equal to or greater than 80% of the longest span of the structure proposed in this project i.e. 28 meters and 40% of the length of longest Major Bridge/ ROB/ flyover or 2 km, whichever is less as a result of which, the Bidder fails to meet the minimum eligibility criteria of Clause 2.2.2.2 (iii) of RFP.**
Hence, the bidder is Non-Responsive.
