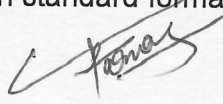

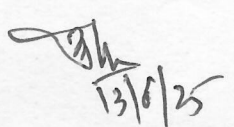

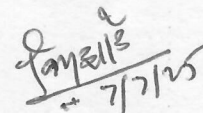
2/6 - M/s. C.B. Bikkad Engineers & Contractors:

5/6 - S & B Infrastructure Developers:

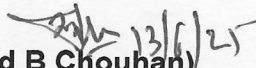
- a) Similar experience as Clause 1.3.1.(b) of Section IX - Form for Qualification information.

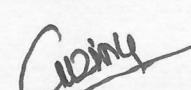
5/6 - OM Construction:

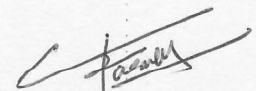
- a) Similar experience as Clause 1.3.1.(b) of Section IX - Form for Qualification information.
 - b) Work programme as per section VII of Schedule- F has not submitted.
 - c) Qualification information- Form 4A, Form-7, Form-7A and Form-11 has not been submitted as per RFP.
5. As per RFP, some shortcomings have been noted in the documents uploaded by the bidders on the e-Tender portal. The Committee unanimously decided to seek clarification over the above shortcomings from 2 bidders, so as to complete / finalize the "Technical evaluation" of the received e-bids.
6. Accordingly, vide RO-Nagpur's Office letter No. 1036 & 1037 dated 03.07.2025, the bidders were requested to provide clarifications. The bidder bearing no. 6/6 M/s Om Construction has submitted the clarification but it is found that the bidder is not eligible as per 1.3.1(b) of RFP. Further, it is also noted that the bidder bearing no. 2/6 did not submitted the clarification as sought by this office.
7. The detailed "Technical Evaluation Report" of the Committee based on original submission and clarification received is placed below at **Annexure-III**.
8. The Committee hereby recommends to declare the 2 bidders at Sr. No. 3/6 and 4/6 of table under Para-3 above as **"Technically Responsive"**.

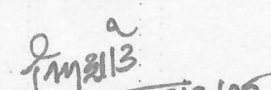
In view of the above, this Committee herewith recommends:
