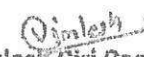

- b) Singh Sahab Travels.

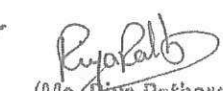
5. A communication may also be issued through mail / letter to all the bidders informing them of the outcome of the technical evaluation.
