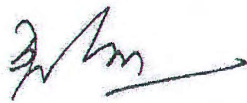
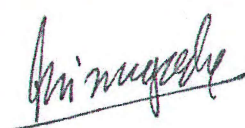
- a) The GST registration certificate not submitted.

- A. To upload the "Detailed Technical evaluation Report" of the bid evaluation Committee on the e-tendering portal of NHAI.

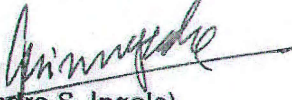

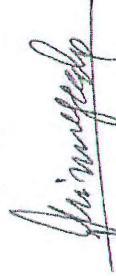
