Gentleman,

This has reference to the subject cited consultancy work and proposal submitted on 17.07.2025 by you in response to RFP for the assignment of subject work, the Competent Authority has approved your financial proposal for an amount of **Rs.12,82,94,809/- (Rupees Twelve Crore Eighty Two Lakhs Ninety Four Thousand Eight Hundred and Nine only)** excluding GST.

2. In this regard, it is requested to furnish **Performance Security** within a period of 15 days from the date of issuance of this Letter of Award (LOA), for an amount of equivalent to **5% of the Contract price i.e., Rs.64,14,740/- (Rupees Sixty Four Lakh Fourteen Thousand Seven Hundred and Forty only)**. The Performance Security shall be valid for a period of 62 months, i.e., up to 2 months beyond the expiry of the Contract period of 60 months, as per Clause 10.1 of Section-2 of the RFP and shall be submitted in the format specified in Appendix-I of the RFP.

3. The Interview/Interaction of Key Personnel with the Expert Team of NHAI shall be conducted at a suitable date, as per NHAI Policy Circulars No. 10.2.35/2024 dated 23.01.2024 and 10.2.36/2024 dated 15.05.2024.

4. Upon submission and confirmation of the **Performance Security** from the beneficiary bank and subsequent successful completion of the interview/interaction of Key Personnel by the Expert Team of NHAI, **you shall be required to sign the Contract Agreement with NHAI.** Thereafter, the services shall commence immediately as per the Contract provisions.

It is further informed that the proposed Key Personnel Mr. K Kiran Kumar, for the position of Resident cum Maintenance Engineer-1 (HMRE-1) has already been interviewed for another project under RO-Hyderabad. In this regard, you are requested to submit an alternate replacement CV for the said position, who gets equivalent/better score than the original key personnel submitted during Technical Bid evaluation for the subject project. As per NHAI Policy Circular No. 10.1.35/2022, the Consulting Firm shall submit the alternate/replacement CV within a period of 7 days from the date of this intimation.

6. You are also required to ensure that your team establishes an office at site/project location with all necessary infrastructure and communication facilities immediately after signing of the Agreement.

7. As per Clause 3.4 (vii) (b) & (f) of Section-2 of RFP, in case the information contained in the CV for the duration in which the key personnel was employed by the firm proposing his candidature is found incorrect/ fake/ inflated at any stage, action including termination of the Consultancy agreement and debarment upto 2years by NHAI on the personnel and the Firm CV and the consultancy firms shall have to refund the salary and perks drawn in respect of such personnel.
