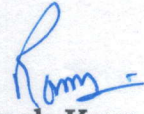
4. The Authority will issue specific LOA for each project and work will be executed as per the terms and conditions specified in the Contract Agreement signed between Authority and the Contractor.

Any of the Empanelled entity which has been blacklisted or barred **or declared Non-Performer by the Ministry of Road Transport & Highways or its implementing agencies; NHAI/ NHIDCL/State PWDs**, from participating in any project, and the bar subsists as on the due date shall not be eligible to submit the quotation.

7. All Empanelled Contractors are requested to nominate an authorized representative and also share contact details (Phone no., e-mail etc.) for communication with NHAI, RO-Chandigarh in future.
