1/2	M/s Devraj Global Infracon	The bidder M/s Devraj Global Infracon has failed to meet the eligibility criteria required as per clause No. 4.4 A (b) of Section-II of RFP as no eligible project experience for the required criteria has been found. Further, the bidder has failed to meet the bid capacity requirement as per clause 4.6 of Section-II of RFP. Accordingly, the bidder M/s Devraj Global Infracon has been declared as Non-Responsive.
